RESOLUTION

December 16, 2020

WHEREAS, on December 18, 2019, the Board of Chosen Freeholders entered into an Agreement with Gerard Breton, M.D., Karabi Sinha, M.D. and Dante Ragasa, M. D., to provide Forensic Pathology Services for the Ocean County Medical Examiner; and

WHEREAS, due to the unforeseen increase in the number of autopsies and the quantity of these services needed beyond the scope of the parties' Agreement were necessitated in an estimated amount of \$50,000.00; and

WHEREAS, funds shall be made available in Account No. 016-286-4414.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY AS FOLLOWS:

1. The Freeholder Director and the Clerk of the Board are hereby authorized and directed to execute an amendment to the 2020 Agreement with Gerard Breton, M.D., Holmdel, NJ; Karabi Sinha, M.D.(Pathology Consultation Services, LLC) Manalapan, NJ and Dante Ragasa, M.D., Hamilton, NJ, increasing each agreement in the amount of \$50,000.00.
2. This amendment is awarded in accordance with the provisions of N.J.S.A. 40A:11-5.1 which recognize that Funeral services such as those required in connection with this Agreement constitute professional services as defined therein.
3. A notice of this action shall be published once as required by law.
4. The contract number shall be placed on all documents pertaining to this Agreement.
