**RESOLUTION**

April 15, 2020

WHEREAS, a current contract exists for the bid **PLUMBING SERVICES** which was awarded on May 1, 2019 and assigned contract number B2019-63; and

WHEREAS, the contract terms included an initial award period of one (1) year and the County reserved the right to extend the contract for one (1) additional year by mutual agreement between the County and the Contractor at no increase in base price; and

WHEREAS, the Ocean County Department of Buildings and Grounds is requesting approval to extend the current contract for one (1) additional year as mentioned above and the Contractor has agreed to such terms in writing;

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF CHOSEN FREEHOLDERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY as follows:

1. The Purchasing Agent and Clerk of this Board are hereby authorized and directed to enter into an extended contract with **Timothy Peters Plumbing and Heating Co., Inc.**, accepting their request for the continued furnishing and delivery of Plumbing Services for the County of Ocean for the extended contract period of May 1, 2020 through April 30, 2021 under the same terms and conditions.

2. Be it further resolved that certified copies of this Resolution shall be made available to the County Auditor, County Purchasing Agent, Department of Finance, Ocean County Department of Buildings and Grounds and Timothy Peters Plumbing and Heating Co., Inc., the successful bidder.
