WHEREAS, the County of Ocean received five (5) responses to the solicitation; and

WHEREAS, the responses received by the County of Ocean were reviewed by the Evaluation Committee designated in the Request for Qualifications in accordance with the selection criteria established by the Board of Commissioners and contained in the Request for Qualifications; and

WHEREAS, the Ocean County Consultant Selection Review Committee has recommended that the Board of Commissioners accept the qualifications of Auction Liquidation Services for On-line Auction Services for Vehicles and Equipment, as more specifically set forth below; and

WHEREAS, the County desires to accept Auction Liquidation Services cost proposal option #2: Seller Premium/Commission of 0% and the Buyer's Premium of 7%.
