## RESOLUTION

December 20, 2023

WHEREAS, there exists a need to provide Electronic Monitoring services for Juveniles as proposed by the 2024 Comprehensive Youth Services Commission Plan approved by the Ocean County Board of Commissioners on December 20, 2023; and

WHEREAS, Request for Proposal Procedures have been followed in accordance with N.J.S.A. 19:44A-20.1 for the services listed above; and

WHEREAS, the Ocean County Youth Services Commission has received and reviewed proposals for such services and recommends an Agreement with Bright Harbor Healthcare to provide such services; and

WHEREAS, funding will be made available in the amount of \$150,000.00, contingent upon the adoption of the 2024 Temporary Budget, which shall be appropriated from account number 017-819-AC84 to cover the cost of the 2024 contract; and

WHEREAS, the County reserves the right to terminate this contract at any time during the contract term if sufficient funds are not available and appropriated to cover the cost of same.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Commissioner Director and the Clerk of the Board are hereby authorized and directed to enter into and execute an Agreement with Bright Harbor Healthcare, 160 Highway 9, Bayville, NJ 08721 in the amount of \$150,000.00 for the provision of the services set forth above.
- 2. The term of this Agreement will be for a period of twelve (12) months commencing on January 1, 2024 and expiring on December 31, 2024, with an option to renew for two (2) additional twelve (12) months pending positive monitoring and submission of required reports, and the availability and appropriation of sufficient funds to meet the obligations of Ocean County hereunder,
- 3. Copies of the Resolution together with a copy of the Agreement for such services set forth above shall be placed on file and be kept available for public inspection in the Office of the Clerk of the Board during normal business hours.
