

WHEREAS, after the receipt and examination of same, the County Director of Purchase has now recommended to this Board that the lowest qualified bid, according to specifications, namely that of, RICH TREE SERVICE, INC. be accepted.

Contract will be awarded on a line item basis. Secondary contracts will be solicited, if necessary, from other bidders at the low bidder rate. Services under secondary contracts will be requested from next low bidders until a sufficient number of tub grinders is available for completing the work requirements.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract for the furnishing and delivery of Tub Grinder Services for the County of Ocean, for the contract period from date of award through August 1, 2024, a period of one (1) year, OR until delivery is complete unless otherwise stated.
