RESOLUTION

February 7, 2024

WHEREAS, on October 4, 2023 a resolution was adopted awarding a purchase order to Van Cleef Engineering Associates, LLC for Road Design Services for the Reconstruction and Resurfacing of Portions of Certain County Roads, Contract 2024B, under contract QP2022-174 for the lump sum fee of ONE HUNDRED NINETY SEVEN THOUSAND FOUR HUNDRED THIRTY EIGHT AND 95/100 DOLLARS (\$197,438.95); and

WHEREAS, it has been determined that additional Road Design Services be conducted in the project area; and

WHEREAS, funds are available in Account Number 300-185-X006-6600 in the amount of TEN THOUSAND NINE HUNDRED THREE AND 65/100 DOLLARS (\$10,903.65) to cover this additional work; and

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the project specific proposal is amended to include these additional Road Design Services for the Reconstruction and Resurfacing of Portions of Certain County Roads, Contract 2024B, in the County of Ocean.
