

- 1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Rencor, Inc., accepting their bid in the total amount of \$4,106,036.35 for Replacement of Duck Farm Bridge (Structure No. 1506-013), Hooper Avenue (C.R. 631) over Cedar Bridge Branch of the Metedeconk River, Brick Township, in accordance with plans and specifications prepared by the County Engineer. All work under this Contract shall be completed within three hundred sixty five (365) calendar days.
- 2. The Department of Finance has certified that funds are available in Account No. 422-185-X210 in the amount of \$3,362,964.74; Account No. 301-185-X210 in the amount of \$197,950.00 and Account No. 417-185-C907 in the amount of \$545,121.61 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations. Award of this project is contingent upon the N.J.D.O.T Commissioner's approval.
- 3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2022-105E.
- 4. BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to each of the following:
 - a. County Auditor;
 - b. County Department of Purchasing;
 - c. Department of Finance; and
- d. County Engineer who shall see that the successful bidder enters into a proper contract for the faithful performance of their bid and that said contract is duly filed with the Clerk of this Board; and who shall see that the successful bidder furnishes to the County of Ocean a properly executed surety company bond for the faithful performance of their contract.
