RESOLUTION

November 6, 2024

WHEREAS, pursuant to N.J.S.A. 19:44A-20.4 et seq., the County of Ocean solicited a Request for Qualification for Online Auction Services for Vehicles and Equipment; and

WHEREAS, the County of Ocean received two (2) responses to the solicitation; and

WHEREAS, the responses received by the County of Ocean were reviewed by the Evaluation Committee designated in the Request for Qualifications in accordance with the selection criteria established by the Board of Commissioners and contained in the Request for Qualifications; and

WHEREAS, the Ocean County Consultant Selection Review Committee has recommended that the Board of Commissioners accept the qualifications of Auction Liquidation Services/USGOVBID for Online Auction Services for Vehicles and Equipment, as more specifically set forth below; and

WHEREAS, the County desires to accept Auction Liquidation Services/USGOVBID cost proposal option for Seller Premium/Commission of 0% and the Buyer's Premium of 7%.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY AS FOLLOWS:

1. The Director and Clerk of the Board are hereby authorized to execute an agreement with Auction Liquidation Services/USGOVBID, 300 Commerce Drive, First Floor, Tinton Falls, NJ, 07753, for the provision of Online Auction Services for Vehicles and Equipment for the period of November 16, 2024, through November 15, 2026, on a when and as needed basis.
2. A copy of the adopted resolution, together with the fully executed agreement, shall remain on file and available for public inspection in the Office of the Clerk of the Board of Commissioners during normal business hours.

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be made available to Auction Liquidation Services/USGOVBID, County Counsel, Department of Finance, Department of Parks and Recreation, Department of Purchasing and Department of Vehicles Services.
