WHEREAS, on April 2, 2025, the Ocean County Board of Commissioners awarded a Contract for the furnishing and delivery of **MATERIAL HAULING SERVICES** to Herman's Trucking, Inc., and was assigned Contract No. B2025-38; and

WHEREAS, due to a clerical error, it is now necessary to amend Resolution No. 2025000412 and the Contract to reflect the correct term of 5/1/2025 through 4/30/2027.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:
