WHEREAS, the Ocean County Board of Commissioners has determined a need exists for a Third Party Administrator for Healthcare Reimbursement Account Services within the Department of Employee Relations; and

WHEREAS, the County of Ocean has publicly solicited a Request for Qualifications for such work in accordance with the requirements of N.J.S.A. 19:44A-20.4; and

WHEREAS, two (2) proposals were received and reviewed by Employee Relations and the Ocean County Consultant Selection Review Committee in accordance with the criteria approved by the Ocean County Board of Commissioners and set forth in the Request for Oualifications; and

WHEREAS, based upon its review, the Consultant Selection Review Committee has reviewed the proposals submitted and recommends the firm listed herein is qualified for the necessary services:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The firm set forth above is qualified and eligible to provide Third Party Administrator for Healthcare Reimbursement Account Services for the necessary services from the date of Resolution through December 31, 2024, with the option to extend for up to two (2) additional one (1) year terms.
- 2. The services provided will be based upon a project specific proposal, when and as needed.
- 3. The contract number shall be placed on all paper, documents, invoices, and vouchers pertaining to the project specific proposal.
- 4. Funds for this service will be made available contingent upon the adoption of the 2024 Temporary County Budget and 2024 County Budget from Account No. 016-045-4018 and based upon the negotiated amount.
