Pursuant to N.J.S.A. 19:44A-20.4 et seq., the County of Ocean requests proposals from firms capable of providing all required services in the update of Ocean County's 2008 Comprehensive Farmland Management Plan until project completion.

The successful vendor(s) must have a minimum of three (3) years' experience in providing professional planning and consulting services associated with farmland preservation in New Jersey. Experience with the State Agriculture Development Committee is highly preferred.

SCOPE OF WORK

Over the past several years the State Agriculture Development Committee (SADC), who has State oversight of the Farmland Preservation Program, has been working on methods to revise it to ensure that their available limited funding assistance is applied to the highest quality farms in each county. One of these methods was the requirement for each county to develop a specific Farmland Preservation Plan to ensure that all the county programs are consistent with the new State regulations governing the Farmland Preservation Program.

In 2008, Ocean County completed the task of compiling the Ocean County Comprehensive Farmland Management Plan (the Plan). The primary purpose of completing the Plan was to provide a vision and strategy for the preservation of the County's agricultural resources. The Plan prioritizes farmland for preservation and was based upon input from local farmland owners, residents, municipal officials, a number of County agencies and departments, and the Board of Chosen Freeholders. The Plan conforms to all the updated SADC guidelines that determine the eligibility for properties seeking to apply to the Farmland Preservation Program. The Plan can also be used by Ocean County to apply for a Planning Incentive Grant (PIG) from the SADC, which is the only program instituted at the County level that qualifies for any type of significant State funding assistance for farmland preservation efforts. The completion of the Plan was a requirement for eligibility into the State PIG Program.

In order to ensure that the Plan remains relevant and that it can continue to be utilized as an effective planning tool in the preservation of farmland in Ocean County, it has been determined that an update of the Plan is required. Updated GIS data will also be required for the Plan update.

The Comprehensive Farmland Preservation Plan Update will address sections of the Plan in which there is updated data available (such as the Census of Agriculture, Tax Assessment data, Preserved Lands, Financial Analysis, New State Regulations. Etc.). The Plan Update will be consistent with the SADC guidelines and will update the following chapters (as needed):

- 1. County Agricultural Land Base** – description of the agricultural characteristics and trends. This includes the location and size of agricultural land, soil characteristics, water sources, Census of Agricultural statistics.

2. Overview of the County's Agricultural Industry – documents the County's existing agricultural industry including shellfish aquaculture and marine fisheries, crop trends, market value, support services and industries.

3. Land Use Planning – details consistency with local municipal and state plans including special resources areas (Pinelands), land use trends, sewer service areas and water supply areas, transfer of development rights.

4. Overview of the County's Farmland Preservation Program – identifies and updates the agricultural development areas, identifies target farms throughout the County, preserved farmland, consistency with the SADC Strategic Targeting Project, Eight Year programs, consistency with open space initiatives, monitoring of preserved farmland.

5. Future Farmland Preservation in Ocean County – program goals and criteria are identified, funding plan for preserving farmland in the future, staff resources and factors limiting farmland preservation implementation. A financial plan demonstrating how to leverage existing funds using option agreements, installment purchases, and donations will also be included.

6. Economic Development – using the Department of Agriculture's Economic Development Strategies, the Plan describes the agricultural industry in Ocean County including aquaculture and strategies for retention, expansion and recruitment.

7. Natural Resource Conservation – describes existing conservation programs including coordination with federal and state conservation programs, energy conservation, and water management planning.

8. Sustainability, Retention and Promotion of the Agricultural Industry – addresses right to farm support, mediation, and strategies for supporting the agricultural industry in the future in Ocean County.

All maps in the document will be updated to reflect 2025 tax assessment data and newly preserved land. Existing County documents will be referenced if they have been updated since the completion of the 2008 Plan.

The vendor will also work closely with County officials to make sure the Plan meets the farmland preservation goals of the County. In addition, as part of the update the vendor will work with the County to facilitate and participate in up to two (2) public hearings as recommended by SADC.

Deliverables

The vendor will also produce a series of updated color maps using ArcGIS technology for this project, including:

- Soils Map
- Map of all preserved farms in Ocean County
- Agriculture Development Areas (ADA) Map
- Map of target farms in Ocean County
- County Project Areas Map
- Farmland meeting the Agricultural Soils Minimum Eligibility Criteria as defined by the SADC
- Farmland meeting the Tillable Land Minimum Eligibility Criteria as defined by the SADC
- Farmland meeting the both the Agricultural Soils and Tillable Land Minimum Eligibility Criteria

The vendor will deliver a draft ready for review within four to six months upon the commencement of the contract. The vendor will then finalize the Plan based upon comments received.

The vendor will also attend up to four (4) meetings of the CADB and/or the Land Preservation Department, including the public meetings. It is anticipated that any public meetings that are held as part of this plan will be held on the same meeting days as the CADB regular meetings.

AWARD

INDEMNITY CLAUSE

The proposer, if awarded a contract, agrees to protect, defend and save harmless the County against any damage for payment for the use of any patented material process, article or device that may enter into the manufacture, construction or form a part of the work covered by either order or contract, and he further agrees to indemnify and save harmless the County from suits or actions of every nature and description brought against it, for, or on account of injuries or damages received or sustained by any party or parties by, or from any of the negligent acts of the contractor, his servants or agents.

INSURANCE REQUIREMENTS

The contractor shall maintain primary insurance to protect against all claims under Worker's Compensation, Comprehensive General Liability and Automobile. Except for Worker's Compensation, all coverage shall apply as primary coverage with respect to any other insurance or self-insurance program afforded to the County. There shall be no endorsement or modification of this coverage to make it excess over other available insurance/coverage; alternatively, if the CGL and umbrella, excess of reinsurance states that it is pro rata, it shall be endorsed to be primary with respect to the County. Primary coverage shall be subject to approval for adequacy of protection as per the following limits:

Worker's Compensation

Such equal employment opportunity shall include, but not be limited to the following: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the Public Agency Compliance Officer setting forth provisions of this nondiscrimination clause.

The CONTRACTOR shall, at its own expense, appear, defend and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the COUNTY'S grievance procedure, the CONTRACTOR agrees to abide by any decision of the COUNTY which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the COUNTY or if the COUNTY incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the CONTRACTOR shall satisfy and discharge the same at its own expense.

Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the COUNTY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.
