**RESOLUTION**

**December 4, 2024**

**WHEREAS**, the Ocean County Board of Commissioners has developed a Recovery Plan for the purposes of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) through the American Rescue Plan Act (ARPA), a component of which is to facilitate evidence-based curriculum and programming to prevent, identify, and intervene in instances of human trafficking and raise awareness in the community; and

**WHEREAS**, on October 18, 2023, the Ocean County Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of Human Trafficking Prevention; and

**WHEREAS**, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

**WHEREAS**, on December 20, 2023, a Competitive Contract was awarded to RWJBH Behavioral Health, Prevention and Recovery, Inc., 1691 Route 9, Toms River, NJ 08755 by the Ocean County Board of Commissioners to provide **Human Trafficking Prevention** for the period of January 1, 2024 through December 31, 2024, with an option to renew up to one (1) additional twelve month period, and assigned Contract No. CC2023-151; and

**WHEREAS**, the County now wishes to extend the contract with RWJBH Behavioral Health, Prevention and Recovery, Inc. for a twelve (12) month period at no additional cost from January 1, 2025 through December 31, 2025 to allow the vendor to complete performance and contract deliverables; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:**

1. The Director and Clerk of the Board are hereby authorized to execute an Amendatory Agreement with RWJBH Behavioral Health, Prevention and Recovery, Inc. to provide Human Trafficking Prevention for the period of January 1, 2025 through December 31, 2025.
2. The Director and the Clerk of the Board are hereby authorized and directed to execute any necessary subsequent documents.
3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said agreement.

**BE IT FURTHER RESOLVED** that certified copies of the Resolution shall be made available to Ocean County Counsel, County Auditor, County Comptroller, Director of Human Services, and RWJBH Behavioral Health, Prevention and Recovery, Inc.
