RESOLUTION

August 16, 2023

WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Small Bridge Design Services for Replacement of Dover Road Bridges, Structure No. 1512-006 and 1512-007, Dover Road over Tributary to Middle Branch of Cedar Creek, Lacey Township, Ocean County; and

WHEREAS, the Board considers it necessary and desirable to engage a Consultant Design service firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on December 21, 2022 and referred to as contract number QP2022-175; and

WHEREAS, Johnson, Mirmiran & Thompson, Inc. is qualified to provide the required Small Bridge Design Services in accordance with their proposal at a not to exceed cost of \$297,896.00; and

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The Board of Commissioners does hereby authorize the issuance of a purchase order in an amount not to exceed \$297,896.00 to Johnson, Mirmiran & Thompson, Inc. for Small Bridge Design Services from Capital Budget Account Number 422-185-X206-6600; and
