**RESOLUTION**

**May 6, 2026**

**WHEREAS**, the County of Ocean previously awarded a Professional Services Contract for Radiology and Other Medical Imaging Services to New Jersey Imaging Network pursuant to Resolution No. 2025001844, adopted December 17, 2025, for the period of January 1, 2026 through December 31, 2026, in an estimated amount not to exceed \$75,000.00; and

**WHEREAS**, New Jersey Imaging Network is unable to honor their contract submission requirements; and

**WHEREAS**, as a result, the County has determined that it is necessary to rescind the award in the best interest of the County to ensure continuity of services; and

**WHEREAS**, the responses received for this Request for Proposals were previously reviewed and ranked by the Ocean County Consultant Selection Review Committee in accordance with the established evaluation criteria; and

**WHEREAS**, the next highest ranked and responsive vendor has been identified as Atlantic Medical Imaging, LLC; and

**WHEREAS**, Atlantic Medical Imaging, LLC has agreed in writing to honor its original proposal pricing and terms as submitted in response to the Request for Proposals; and

**WHEREAS**, it is in the best interest of the County to proceed with award to Atlantic Medical Imaging, LLC;

**NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The aforementioned Resolution No. 2025001844, adopted December 17, 2025, awarding a Professional Services Contract to New Jersey Imaging Network is hereby rescinded.
2. The Director and Clerk of the Board are hereby authorized and directed to execute an Agreement for Radiology and Other Medical Imaging Services with Atlantic Medical Imaging, LLC, for the Ocean County Workers' Compensation Program, for the period beginning date of award, May 6, 2026 through December 31, 2026, in an amount not to exceed \$50,000.00, with the option to extend for up to two (2) additional one (1) year terms.
3. Funding for this contract shall be made available in Trust Account #231-080-0308 for all workers' compensation expenses payable through the County's Third Party Claims Administrator.
4. All other provisions of the original Request for Proposals shall remain in full force and effect.

5. This contract is awarded as a "Professional Service" in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a).
6. A notice of this action shall be published once as required by law.

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to the Ocean County Finance Department, Employee Relations Department, Division of Risk Management, and Atlantic Medical Imaging, LLC.
