WHEREAS, on January 4, 2022, pursuant to legal advertisements therefor, sealed bids were received for the furnishing and delivery of EQUIPMENT AND SUPPLIES FOR COMMUNICATION SYSTEMS for the County of Ocean; and

WHEREAS, on February 2, 2022, Contract B2022-14, Item No. 1 was awarded to CLOUD-AGE IT; and

WHEREAS, the County Purchasing Agent has requested Contract B2022-14, Item No. 1 awarded to Cloud-Age IT be rescinded due to a clerical error; and
