## RESOLUTION

May 6, 2026

**WHEREAS**, a current contract exists for the bid titled GARBAGE AND TRASH REMOVAL which was awarded on July 6, 2023 and assigned contract number B2023-121; and

**WHEREAS**, the contract terms included an award period of three (3) years and the County reserved the right to extend the term of the contract for two (2) additional one (1) year terms by mutual agreement between the County and the contractor with no increase in base price; and

**WHEREAS**, the Buildings and Grounds Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and Waste Management of New Jersey, Inc. has agreed to such terms in writing.

**WHEREAS**, pursuant to N.J.A.C. 5:30-5.4, the County has established a reasonable estimated maximum dollar value of \$473,000.00 for the term of this contract, based on historical procurement data for comparable goods or services. The County further reserves the right to increase quantities by up to twenty percent (20%) of the maximum awarded amount at the unit prices bid, in accordance with N.J.A.C. 5:30-11.3; and

**WHEREAS**, funds for the materials or services described herein shall be made available through operating and expense (O&E) accounts, trust accounts, grant accounts, or capital accounts maintained by, but not limited to, the following departments:

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with Waste Management of New Jersey, Inc., accepting their request for the continued furnishing and delivery of GARBAGE AND TRASH REMOVAL for the extended contract period of July 6, 2026 through July 5, 2027 under the same terms and conditions.
