WHEREAS, on April 6, 2022, a resolution was adopted for the furnishing and delivery of CORRUGATED POLYETHYLENE DRAINAGE PIPE for the County of Ocean; and

WHEREAS, upon further review of the contract documents, the County Purchasing Agent has recommended to the Board that an Amendment to the resolution is necessary due to a typographical error page two (2) of the Resolution incorrectly lists wrong vendor: and

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Ferguson, Inc. accepting their bid for the furnishing and delivery of Corrugated Polyethylene Drainage Pipe for the County of Ocean, for the contract period from April 6, 2022 through April 5, 2023, a period of one (1) year or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15, as follows:
- 2. The Director and Clerk of this Board are hereby authorized and directed to amend the Resolution for the furnishing and delivery of Corrugated Polyethylene Drainage Pipe for the County of Ocean.
- 3. All other provisions of the resolution and contract documents shall remain in full force and and effect.
- The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2022-39.
- BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Purchasing, Department of Finance, County Road Supervisor, and Ferguson, Inc. the successful bidder.
