RESOLUTION

August 19, 2026

WHEREAS, on June 17, 2026, the County of Ocean awarded a Contract for the furnishing and delivery of **MARINE MAINTENANCE, REPAIR AND UPGRADE SERVICES FOR VARIOUS COUNTY WATER VESSELS**, and was assigned Contract No. B2026-68; and

WHEREAS, due to a scrivener's error, the awarding Resolution only reflected the need to rebid the furnishing and delivery of **MARINE MAINTENANCE, REPAIR AND UPGRADE SERVICES FOR VARIOUS COUNTY WATER VESSELS** for the Central and Southern Regions and did not include the Northern Region; and

WHEREAS, as indicated in the Award Method of the bid specifications, the County reserves the right to award up to two (2) vendors per geographic region and now finds it necessary to amend Resolution No. 2026000770 to reflect the authority to obtain an additional vendor for the Northern Region.

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, that Resolution No. 2026000770 is hereby amended to reflect the authority to rebid the furnishing and delivery of **MARINE MAINTENANCE, REPAIR AND UPGRADE SERVICES FOR VARIOUS COUNTY WATER VESSELS** to include an additional vendor for the Northern Region, with all other terms and conditions of Resolution No. 2026000770 to remain in full force and effect.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Parks Department and Sheriff's Office.
