RESOLUTION

July 16, 2025

WHEREAS, there exists a need to provide Inmate Healthcare Services for the County of Ocean Department of Corrections; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, on August 18, 2021, the Ocean County Board of Commissioners entered into a Competitive Contracting Agreement with CFG Health Systems, LLC for the purpose of providing Inmate Healthcare Services for the County of Ocean Department of Corrections; and

WHEREAS, the contract terms included an initial award period of three (3) years, and the County reserved the right to extend the contract for two (2) additional one-year periods; and

WHEREAS, the Ocean County Department of Corrections desires to extend the current contract for the 2nd additional one-year period of 9/1/2025 through 8/31/2026, and the Contractor has agreed to such terms in writing; and

WHEREAS, funds for the period of 9/1/2025 through 12/31/2025 shall not exceed \$202,775.68 for management fees, and shall be made available under Account No. 016-200-4803 Inmate Healthcare Services; and

WHEREAS, funds for services to be provided for the remainder of the extended contract term, in an amount not to exceed \$405,551.32, shall be contingent upon adoption of the 2026 Temporary County Budget with the balance to be available upon adoption of the 2026 County Budget, at which time the Department of Finance will notify the appropriate County official when funds have become available; and

WHEREAS, pass through operational expenses shall be encumbered on an as-needed basis, by Purchase Order Only.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of the Board are hereby authorized to execute an amendatory contract with CFG Health Systems, LLC, at 765 Route 70 East, Suite A-100, Marlton, NJ 08053, for the continued furnishing and delivery of Inmate Health Care Services for the County of Ocean for the period of September 1, 2025 to August 31, 2026 under the same terms and conditions.

2. The contract number must be placed on all paper documents, invoices and vouchers pertaining to this Agreement, being CC2021-94.
3. A certified copy of this Resolution, together with a copy of the Agreement executed by both parties, shall remain on file and be available for public inspection at the Office of the Clerk of the Board of Commissioners.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to: CFG Health Systems, LLC, County Comptroller; County Auditor; Department of Corrections; and County Counsel.
