

The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Brennan Brothers Contracting, LLC, accepting their bid for the Demolition of Structures in accordance with plans and specifications prepared by Remington & Vernick Engineers, Consulting Engineer. Project to be completed within 60 calendar days of Notice to Proceed. Project to have a Liquidating Damage Clause of \$500.00 per day after date of Contract completion. Project to start on or about June 2023.
- 2. The Department of Finance has certified that funds are available in Account No. 225-155-0151 in the amount of \$ 58,291.00, to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.
- 3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2023-110CE.
- 4. **BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to each of the following:
 - a. County Auditor;
 - b. County Director of Purchase;
 - c. Department of Finance; and
- d. Remington & Vernick Engineers, Consulting Engineer who shall see that the successful bidder enters into a proper contract for the faithful performance of their bid and that said contract is duly filed with the Clerk of this Board, and who shall see that the successful bidder furnishes to the County of Ocean a properly executed surety company bond for the faithful performance of their contract.
