RESOLUTION

August 2, 2023

WHEREAS, on December 15, 2021 a resolution was adopted awarding a purchase order to Colliers Engineering for Wireless Fire Alarm Upgrade Project for the lump sum fee of \$53,200.00 to provide Phase I site audit services; and

WHEREAS, on August 3, 2022 a Resolution was adopted awarding a purchase order to Colliers Engineering & Design for Energy Consulting Services for the Wireless Fire Alarm Upgrade Project, for the lump sum fee of \$22,000.00 associated with Phase II design and construction documents; and

WHEREAS, it has been determined that the need exists for continued services for Phase III procurement support, construction administration and turn-up inspection; and

WHEREAS, Colliers Engineering & Design has provided a project specific proposal to provide these services, dated July 3, 2023 at a not to exceed cost of \$61,250.00 under Contract No. QP2022-110; and

WHEREAS, funds for these services shall be available from Account Number 301-010-X221 to cover additional work; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A. 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED by the OCEAN COUNTY BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Board does hereby authorize the issuance of a Purchase Order in the amount not to exceed \$61,250.00 to Colliers Engineering & Design for Engineering Design Services associated with Phase III procurement support, construction administration and turn-up inspection services with funding from Account No. 301-010-X221.
2. Certified copies of this Resolution shall be made available to the Ocean County Management & Budget Department, Ocean County Department of Finance, Ocean County Department of Purchasing, Building and Grounds Department and T&M Associates.
