RESOLUTION

December 21, 2022

WHEREAS, the County of Ocean Board of Commissioners, has determined that a need exists for ENERGY SAVINGS REDESIGN OF DOMESTIC WATER HEATER AND PIPING AT NEW JAIL; and

WHEREAS, the Board considers it necessary and desirable to engage an Energy Consulting Services firm from the list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on August 3, 2022 (QP2022-110); and

WHEREAS, the County requested proposals and determined DCO Energy, LLC is qualified to provide the required Energy Consulting Services in accordance with their project specific proposal for Energy Savings Redesign of Domestic Water Heater and Piping at New Jail, dated September 28, 2022 at a not to exceed cost of \$37,500.00; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A. 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Board does hereby authorize the issuance of a Purchase Order in the amount not to exceed \$37,500.00 to DCO Energy, LLC for Energy Consulting Services from Budget Account Number 016-070-4030.
