WHEREAS, the Ocean County Board of Chosen Commissioners, has determined that a need exists for SOUTHERN ANIMAL SHELTER HVAC UPGRADE PROJECT; and

WHEREAS, The Board considers it necessary and desirable to engage an Energy Consulting Services firm from the list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on August 3, 2022 (QP2022-110); and

WHEREAS, the County requested proposals and determined T&M Associates is qualified to provide the required Energy Consulting Services in accordance with their project specific proposal for the Southern Animal Shelter HVAC Upgrade Project, dated March 20, 2023 at a not to exceed cost of \$102,500.00; and
