

RESOLUTION

WHEREAS, the Ocean County Board of Commissioners, has determined that a need exists for a FIRE AND FIRST AID TRAINING CENTER HVAC UPGRADE PROJECT, 200 Volunteer Way, Waretown, New Jersey; and

WHEREAS, The Board considers it necessary and desirable to engage an Energy Consulting Services firm from the list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on August 3, 2022 (QP2022-110); and

WHEREAS, the County requested proposals and determined T&M Associates is qualified to provide the required Energy Consulting Services in accordance with their project specific proposal for the Fire and First Aid Training Center HVAC Upgrade Project, dated May 31, 2023 at a not to exceed cost of \$84,400.00; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A. 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED by the OCEAN COUNTY BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:
