WHEREAS, on April 20, 2022 a resolution was adopted awarding a purchase order to T&M Associates for Energy Consulting Services for Phase 1 Services of Survey, Investigation, Schematic Design with Construction Cost Estimate for the JUVENILE DETENTION CENTER ROOF AND MECHANICAL UPGRADES Project for the lump sum fee of \$58,800.00; and

WHEREAS, it has been determined that the need exists for continued services for design documents, bidding assistance, construction administration and part-time construction observation; and

WHEREAS, T&M Associates has provided a project specific proposal to provide these services, dated June 27, 2023 at a not to exceed cost of \$319,500.00 under Contract QP2022-110; and

WHEREAS, funds for these services shall be available from Account Number 301-070-X310 to cover additional work; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A. 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.
