RESOLUTION

November 19, 2025

WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Uniform and Standard Safety and Evacuation Plans for three (3) County buildings: the County Administration Building at 101 Hooper Avenue; County PEER Building at 129 Hooper Avenue; and County Social Services Building at 1005 Hooper Avenue, Toms River, New Jersey; and

WHEREAS, the Board considers it necessary and desirable to engage the qualified firm identified in a Resolution adopted by the Board of Commissioners on September 30, 2025 and referred to as contract number QP2025-90; and

WHEREAS, Core Consulting Services, LLC, is qualified to provide the required Evacuation and Safety Plans in accordance with their proposal at a not to exceed cost of \$16,000.00.

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The County Purchasing Agent is hereby authorized to issue a purchase order in an amount not to exceed \$16,000.00 to Core Consulting Services, LLC, for Evacuation and Safety Plans from Account Number 016-045-4018 in the amount of \$16,000.00.
2. A notice of this action shall be published once as required by law.
3. The Contract number must be placed on all documents pertaining to this Agreement.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be forwarded to the Ocean County Department of Employee Relations, Finance Department, Purchasing Department, and Core Consulting Services, LLC.
