**RESOLUTION**

**September 30, 2025**

**WHEREAS**, there exists a need for Uniform and Standard Safety and Evacuation Plans for Ocean County Department of Employee Relations; and

**WHEREAS**, the County of Ocean publicly solicited a Request for Qualifications for such work in accordance with N.J.S.A. 19:44A-20.4; and

**WHEREAS**, one (1) firm responded with written qualifications and associated documentation; and

**WHEREAS**, the Consultant Selection Review Committee has reviewed the proposal submitted and has recommended that one (1) firm be qualified to provide Uniform and Standard Safety and Evacuation Plans; and

**WHEREAS**, the response received by the County of Ocean was reviewed by the Ocean County Department of Employee Relations and the Ocean County Consultant Selection Review Committee in accordance with the criteria approved by the Ocean County Board of Commissioners and set forth in the Request for Qualifications; and

**WHEREAS**, the Ocean County Employee Relations Department and the Ocean County Consultant Selection Review Committee has recommended that Core Consulting Services, LLC, 152 Lake Drive, Brooklawn, NJ 08030, is qualified and eligible to provide Uniform and Standard Safety and Evacuation Plans for the period of one (1) year.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. Core Consulting Services, LLC. is qualified and eligible to provide Uniform and Standard Safety and Evacuation Plans on a project specific proposal basis, for the period of one (1) year, from October 1, 2025 through September 30, 2026.
2. A certified copy of this Resolution shall remain on file and available for public inspection in the Office of the Clerk of the Board of Commissioners during normal business hours.
3. The contract number must be placed on all papers, documents, invoices, and vouchers.

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be forwarded to County Counsel, County Auditor, County Comptroller, County Administrator, County Department of Employee Relations | Risk Management Division, and Core Consulting Services, LLC.
