**RESOLUTION**

**WHEREAS**, the County of Ocean previously awarded contracts to CME Associates, LLC for various professional services; and

**WHEREAS**, the County has received formal notification, dated April 24, 2026, that effective January 1, 2026, CME Associates, LLC is now wholly owned by Artheon, Inc., and that all contracts, accounts, and obligations previously held by CME Associates, LLC have been assigned to and assumed by Artheon, Inc.; and

**WHEREAS**, Artheon, Inc. has confirmed in writing the acceptance and assumption of all responsibilities, terms, and conditions of the existing agreements with the County of Ocean

**NOW, THEREFORE, BE IT RESOLVED** by the **BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. Contracts listed in Schedule A, which were previously awarded to CME Associates, LLC are hereby assigned to Artheon, Inc., with principal offices located at 1 Tower Center Boulevard, 20th Floor, East Brunswick, NJ 08816.
2. This action reflects a change in ownership only, with all other terms and conditions of the original contracts and resolutions remaining unchanged.
