## RESOLUTION

December 4, 2024

**WHEREAS**, the Ocean County Board of Commissioners has developed a Recovery Plan for the purposes of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) through the American Rescue Plan Act (ARPA), a component of which is to provide school- and community-based trauma and disaster response interventions; and

**WHEREAS**, on July 19, 2023, the Ocean County Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of Traumatic Loss and Disaster Response for Children; and

**WHEREAS**, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

**WHEREAS**, on September 20, 2023, a Competitive Contract was awarded to Bright Harbor Healthcare, 687 Atlantic City Boulevard, Bayville, NJ 08721 by the Ocean County Board of Commissioners to provide **Traumatic Loss and Disaster Response for Children** for the period of October 1, 2023 through December 31, 2024, with an option to renew up to one (1) additional twelve month period, as more specifically set forth in the Agreement, and assigned Contract No. CC2023-110; and

**WHEREAS**, the County now wishes to extend the contract with Bright Harbor Healthcare for a twelve (12) month period at no additional cost from January 1, 2025 through December 31, 2025 to allow the vendor to complete performance and contract deliverables; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

- 1) The Director and Clerk of the Board are hereby authorized to execute an Amendatory Agreement with Bright Harbor Healthcare to provide Traumatic Loss and Disaster Response for Children for the period of January 1, 2025 through December 31, 2025.
- 2) The Director and Clerk of the Board are hereby authorized and directed to execute any necessary subsequent and related documents.
- 3) The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said agreement.

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to the Ocean County Department of Finance, County Auditor, Department of Human Services, and Bright Harbor Healthcare.
