

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has now recommended to this Board that the lowest qualified bid, according to specifications, namely that of, ABSOLUTE PROTECTIVE SYSTEMS, INC., DIV OF SCIENS BUILDING SO and ALARM & COMMUNICATIONS TECHNOLOGIES, INC. be accepted.

THEREFORE, BE IT RESOLVED by the BOARD NOW. COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:
