**RESOLUTION**

**WHEREAS**, on July 17, 2024, the qualification of an additional Perishable Food Providers was accepted and assigned Contract No. QP2024-73S; and

**WHEREAS**, the terms included services to be provided for the period of one (1) year with the County reserving the right to extend the contract for one (1) additional year by mutual agreement between the County and the provider; and

**WHEREAS**, the Ocean County Department of Juvenile Services is requesting approval to extend the period for the additional one (1) year as mentioned above and the one (1) provider have agreed to such terms in writing;

**WHEREAS**, the contract document will be the Purchase Order, under Account Nos. 016-210-5051 and 016-210-5056, when issued by the Ocean County Department of Purchase, and shall be approved upon funding made available by the Department of Finance, in an amount not to exceed \$50,000.00.

**NOW, THEREFORE, BE IT RESOLVED, by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY** that they accept the qualifications of Bey Lea Dairy, 215 Oak Avenue, Toms River, NJ 08753 for the continued furnishing and delivery of Perishable Food Provider for the County of Ocean for the extended contract period of June 21,2025 to June 20, 2026 with all other terms and conditions remaining the same.
