RESOLUTION

July 17, 2024

WHEREAS, on May 15, 2024, qualifications from three (3) Perishable Food Providers were accepted by the Ocean County Board of Commissioners to provide perishable food for the Department of Juvenile Services, and was assigned Contract No. QP2024-73; and

WHEREAS, the Ocean County Consultant Selection Review Committee recommended and approved the issuance of a supplemental Request for Qualifications for Perishable Food Providers to obtain additional providers; and

WHEREAS, pursuant to N.J.S.A. 19:44A-20.4 et seq., the County of Ocean solicited a Request for Qualifications for Perishable Food Providers No. II; and

WHEREAS, the Ocean County Juvenile Services Department received two (2) responses to the Request for Qualifications for Perishable Food Providers No. II solicitation submitted in accordance with the selection criteria established by the Board of Commissioners and contained in the Request for Qualifications; and

WHEREAS, the Ocean County Consultant Selection Review Committee has now recommended that the Board of Commissioners accept the qualifications of Bey Lea Dairy, as an additional Perishable Food Provider, to be used on an as-needed basis, from date of award until 6/20/2025, with the option to extend for one (1) additional year; and

WHEREAS, funds are available in the aggregate amount not to exceed \$50,000.00 for Contract Nos. QP2024-73 and QP2024-73S; and

WHEREAS, funding shall be encumbered under Account Nos. 016-210-5051-2300 and 016-210-5056-2300; and

WHEREAS, this agreement is awarded in compliance with the provisions of N.J.S.A. 40A:11-5(1) of the Local Public Contracts Law and N.J.S.A. 19:44A-20.4 et seq., the New Jersey "Pay to Play" Law.

NOW, THEREFORE, BE IT RESOLVED, by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY that they do hereby accept the qualifications of Bey Lea Dairy, 215 Oak Avenue, Toms River, NJ 08753, as an additional Perishable Food Provider under Contract No. QP2024-73S, on an as needed basis, to be authorized by purchase order only.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Department of Purchase, Department of Finance, Department of Juvenile Services, and Bey Lea Dairy.
