WHEREAS, on August 2, 2023 a resolution was adopted awarding a purchase order to ATANE Engineers, Architects & Land Surveyors, P.C. for Consultant Material Sampling, Inspection and Testing Services for Reconstruction and Resurfacing of Certain County Roads, Contract 2021A, Various Townships, Ocean County under contract QP2023-68 for the lump sum fee of TWENTY FOUR THOUSAND TWO HUNDRED FIFTY SEVEN AND 40/100 DOLLARS (\$24,257.40); and
