RESOLUTION

**August 6, 2025**

**WHEREAS**, on August 16, 2023 a resolution was adopted awarding a purchase order to ATANE Engineers, Architects & Land Surveyors, P.C. for Consultant Material Sampling, Inspection and Testing Services for Reconstruction and Resurfacing of Certain County Roads, Contract 2021C, Various Townships, Ocean County under contract QP2023-68 for the lump sum fee of TWENTY THREE THOUSAND TWO HUNDRED FIFTY ONE AND 50/100 DOLLARS (\$23,251.50); and

**WHEREAS**, it has been determined that additional Consultant Material Sampling, Inspection and Testing Services be conducted in the project area; and

**WHEREAS**, funds are available in Account Number 300-185-X402-6600 in the amount of SEVEN THOUSAND FOUR HUNDRED SEVENTY AND 00/100 DOLLARS (\$7,470.00) to cover this additional work.

**NOW, THEREFORE, BE IT RESOLVED** by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the project specific proposal is amended to include these additional Consultant Material Sampling, Inspection and Testing Services for Reconstruction and Resurfacing of Portions of Certain County Roads, Contract 2021C, Various Townships, in the County of Ocean.
