WHEREAS, on September 6, 2023, the County of Ocean adopted a Resolution ratifying the award of a Purchase Order to Atlantic Engineering Laboratories, LLC to provide Consultant Material Sampling, Inspection and Testing Services associated with the Stafford Library Construction Project, in an amount not to exceed \$13,200.00, under Contract No. QP2023-68; and

WHEREAS, on February 7, 2024, the County of Ocean adopted a Resolution authorizing a name change from Atlantic Engineering Laboratories, LLC to Atlas LLC; and

WHEREAS, on May 15, 2024, the County of Ocean adopted a Resolution amending the award of the Purchase Order, an increase to the contract in an amount not to exceed \$5,620.00 to provide additional Consultant Material Sampling, Inspection and Testing Services associated with the Stafford Library Construction Project; and

WHEREAS, it has been determined that additional Consultant Material Sampling, Inspection and Testing Services are required until project is complete; and

WHEREAS, funding for these additional services are available through Ordinance #2022-11 entitled Construction of Library Facility, Account No. 9999-422-015-X211, in the estimated amount of \$15,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY that the Project Specific Proposal is hereby amended to provide additional Consultant Material Sampling, Inspection and Testing Services associated with the Stafford Library Construction Project, with funding available through Ordinance #2022-11 entitled Construction of Library Facility, Account No. 9999-422-015-X211, an increase to the contract in the estimated amount of \$15,000.00.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the Ocean County Auditor, County Purchasing Agent, Department of Finance, County Counsel, and Atlas, LLC.
