RESOLUTION

WHEREAS, a current contract exists for the bid titled ROUTE 37 BUS **SERVICE** which was awarded on April 1, 2022 and assigned contract number B2022-36; and

WHEREAS, the contract terms included an award period of two (2) years and the County reserved the right to extend the term of the contract for one (1) additional year by mutual agreement between the County and the contractor with no increase in base price; and

WHEREAS, the Transportation Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and Stouts Charter Service, Inc. has agreed to such terms in writing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with Stouts Charter Service, Inc., accepting their request for the continued furnishing and delivery of ROUTE 37 BUS SERVICE for the extended contract period of April 1, 2024 through March 31, 2025 for a total lump sum of \$897,697.72, under the same terms and conditions.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Transportation Department, and Stouts Charter Service, Inc..
