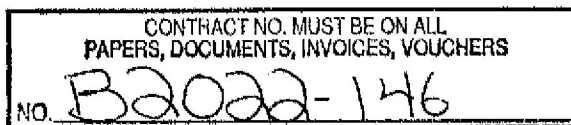

RESOLUTION

July 19, 2023
