## RESOLUTION

WHEREAS, on July 16, 2025, a Contract was awarded for the furnishing and delivery of K9 DOG FOOD AND SUPPLIES NO. III to Meticulous Services LLC for Item Nos. 32, 49, 82, 83, 84, 85, 86, 87, 88, 89, 91, 97, 98, 119, 120, 121, 122, 123, 124, 125, 126, 135, 136 and 147 and was assigned Contract No. B2025-96; and

WHEREAS, the County Purchasing Agent has recommended that the Contract be rescinded from Meticulous Services LLC, as they are unwilling to honor their contract to the County; and

WHEREAS, N.J.S.A. 40A: 11-15(3) provides that in the event no qualified bids were received on two (2) occasions, a governing body may enter into a negotiated contract.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY that K9 DOG FOOD AND SUPPLIES NO. III Item Nos. 32, 49, 82, 83, 84, 85, 86, 87, 88, 89, 91, 97, 98, 119, 120, 121, 122, 123, 124, 125, 126, 135, 136 and 147 awarded to Meticulous Services LLC, are hereby rescinded, as the vendor is unwilling to honor their contract.

BE IT FURTHER RESOLVED that the County Purchasing Agent is hereby authorized and directed to enter into negotiations leading to the furnishing and delivery of K9 DOG FOOD AND SUPPLIES NO. III Item Nos. 32, 49, 82, 83, 84, 85, 86, 87, 88, 89, 91, 97, 98, 119, 120, 121, 122, 123, 124, 125, 126, 135 and 136. Item No. 147 will not be awarded or rebid as it was previously awarded.
