WHEREAS, on May 21, 2024, pursuant to legal advertisements therefor, sealed bids were received for furnishing and delivery of JANITORIAL SUPPLIES for the County of Ocean; and

WHEREAS, on July 17, 2024, Contract B2024-89, Item No. 66 was awarded to PLASTIC EXPRESS, INC.; and

WHEREAS, the County Purchasing Agent has requested Contract B2024-89, Item No. 66 awarded to Plastic Express, Inc., be rescinded as they are unable to honor their contract pricing.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The aforementioned Resolution and Contract dated July 17, 2024, awarding Item No. 66 to Plastic Express, Inc., is hereby rescinded.
- 2. The Director and Clerk of this Board are hereby authorized and directed to enter into an amendatory contract with QUALMAX SUPPLIES for Item No. 66, the next lowest qualified bidder. This vendor has extended this contract to County Cooperative Contract System Participants, Identifier No. CK-02-OC.
- 3. All other provisions of the Resolution and contract documents described above shall remain in full force and effect.
- 4. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2024-89.
