WHEREAS, on December 7, 2022, the Board of Commissioners authorized the acquisition of Software Licensing, Maintenance Support and Consumable Parts for the Tritek Ballot Sorter No II for 2023 and 2024, by purchase order only, in an amount not to exceed \$70,000.00 per year; and

WHEREAS, the Ocean County Board of Elections has a need to purchase additional consumables for the Tritek Ballot Sorter No. II for an additional amount not to exceed \$20,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Director and Clerk of the Board are hereby authorized and directed to execute an Amendatory Agreement with Tritek Systems, Inc. 103 E. Bridle Path, Hockesssin, DE 19707, for the purchase of additional consumables for the Ballot Sorting machine.
- 2. Funds are available for said purchase order to be encumbered against Account No. 016-135-4420 an increase to the contract in an amount not to exceed \$20,000.00
- 3. The purchase order number must be placed on all papers, documents, invoices and vouchers pertaining to this Agreement.
- 4. A certified copy of the Resolution, together with a copy of the Amendatory Agreement executed by the parties, shall remain on file and be available for public inspection at the office of the Clerk of the Board of Commissioners.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be forwarded to Ocean County Counsel, County Board of Elections, County Comptroller, and Tritek Systems, Inc.
