

WHEREAS, on May 21, 2024, pursuant to legal advertisements therefor, scaled bids were received for the RECONSTRUCTION AND RESURFACING OF PRINCETON AVENUE FROM POST ROAD TO BARNEGAT BAY, BRICK TOWNSHIP, County of Ocean, State of New Jersey; and

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has referred all bids to the County Engineer for study and recommendation to the Board; and

WHEREAS, the County Engineer has now recommended to this Board that the lowest qualified bid, according to specifications, namely that of, C.J. HESSE, INC., be accepted for the Reconstruction and Resurfacing of Princeton Avenue from Post Road to Barnegat Bay, Brick Township.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with C.J. Hesse, Inc., accepting their bid in the total amount of \$2,473,619.62, in accordance with plans and specifications prepared by the County Engineer. All work under this Contract shall be completed within One Hundred Fifty (150) calendar days.
- 2. The Department of Finance has certified that funds are available in Account No. 304-185-X209 in the amount of \$1,858,281.62; Account No. 301-185-X202 in the amount of \$40,338.00 and Account No. 424-185-X304 in the amount of \$575,000.00 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations. Award of this project is contingent upon the N.J.D.O.T Commissioner's approval.
