RESOLUTION

June 21, 2023

WHEREAS, on July 6, 2022 the Ocean County Board of Commissioners awarded a Purchase Order to Adams, Rehmann & Heggan Associates, Inc. to provide Land Surveying Services for the OC Natural Lands Trust Fund Program, in an amount not to exceed \$14,970.00, under Contract No. QP2022-71; and

WHEREAS, due to clerical errors, an amendment to adopted Resolution No. 2022000968 is required to reference the correct addendums and resolution number, as follows:

1. On April 20, 2022, the Ocean County Board of Commissioners approved the acquisition of properties identified in **Addendum B** in Berkeley Township under the Ocean County Natural Lands Trust Fund, by resolution **#2022000530**; and
2. On May 18, 2022, the Ocean County Board of Commissioners approved the acquisition of properties identified in **Addendum A** in Berkeley Township under the Ocean County Natural Lands Trust Fund, by resolution **#2022000680**; and

WHEREAS, due to a property classification error, additional funding for proper Land Surveying Services on nine (9) properties is required, reflecting an increase to the contract in the amount of \$5,960.00, for a revised total cost of \$20,930.00.

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. Resolution No 2022000968 is hereby amended to reference the proper addendums and resolution number, as indicated above.
2. The County Purchasing Agent is hereby authorized to amend the Purchase Order to include additional funding in the amount of \$5,960.00, for a revised total cost of \$20,930.00, with funding available in the Natural Lands Trust Fund Account Number 225-155-0151.
3. Certified copies of this Resolution shall be made available to County Administrator, Planning Department, Finance Department, County Auditor, County Counsel, County Natural Lands Trust Fund Advisory Committee and Adams, Rehmann & Heggan Associates, Inc.
