### RESOLUTION

May 15, 2024

WHEREAS, the County of Ocean has the need for Food Services for the Ocean County Jail; and

WHEREAS, on March 13, 2024, the County of Ocean publicly solicited a Request for Competitive Contract Proposals for such services in accordance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. and the New Jersey "Pay to Play" Law, N.J.S.A. 19:44A-20.4 et seq.; and

WHEREAS, the Ocean County Department of Corrections received and reviewed one (1) proposal for said services in accordance with the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the Ocean County Department of Corrections has recommended that a contract for said services be awarded to GD CORRECTIONAL SERVICES, LLC, 461 Watchung Avenue, Watchung, NJ, 07069, for an initial term of three (3) years, commencing on May 1, 2024, in the estimated amount of \$9,000,000.00, plus the option to extend said Agreement for two (2) additional one (1) year terms, as more specifically set forth in that Agreement; and

WHEREAS, funding for services provided during the period of May 1, 2024 through December 31, 2024, in an estimated amount of \$2,000,000.00, shall be made available under Account No. 016-200-4806; and

WHEREAS, funding for services provided for the remainder of the initial three (3) year term (January 1, 2025 through April 30, 2027), in an estimated amount of \$7,000,000.00, shall be made available contingent upon the adoption of the County Temporary Budget and County Budget for the years 2025; 2026, and 2027.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Director and Clerk of the Board are hereby authorized and directed to enter into and execute an Agreement with GD CORRECTIONAL SERVICES, LLC for food services for the Ocean County Jail for an initial term of three (3) years, commencing on May 1, 2024 with the County having the option to extend said Agreement for two (2) additional one (1) year terms, as more specifically set forth in that Agreement.
- 2. The contract number must be placed on all papers, documents, invoices, and vouchers pertaining to this Agreement.
