RESOLUTION

WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Road Design Services for Reconstruction of Cross Street, CR 626 – Phase 1B, Augusta Boulevard to State Highway Route 9, Lakewood Township, Ocean County; and

WHEREAS, the Board considers it necessary and desirable to engage a Consultant Design service firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on December 20, 2023 and referred to as contract number QP2023-163; and

WHEREAS, Dewberry Engineers, Inc. is qualified to provide the required Road Design Services in accordance with their proposal at a not to exceed cost of \$923,458.00; and

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The Board of Commissioners does hereby authorize the issuance of a purchase order in an amount not to exceed \$923,458.00 to Dewberry Engineers, Inc. for Road Design Services from Capital Budget Account Numbers 301-185-X102-6600 and 300-185-X401-6600; and
