WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Road Design Services for Reconstruction and Resurfacing of County Route 526, North County Line Road from Jackson Mills Road to Bennetts Mills Road, Jackson Township, Ocean County; and

WHEREAS, the Board considers it necessary and desirable to engage a Consultant Design service firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on December 20, 2023 and referred to as contract number QP2023-163; and

WHEREAS, Pennoni Associates, Inc. is qualified to provide the required Road Design Services in accordance with their proposal at a not to exceed cost of \$268,943.76; and

NOW, THEREFORE, \mathbf{BE} IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Board of Commissioners does hereby authorize the issuance of a purchase order in an amount not to exceed \$268,943.76 to Pennoni Associates, Inc. for Road Design Services from Capital Budget Account Number 301-185-X308-6600; and
