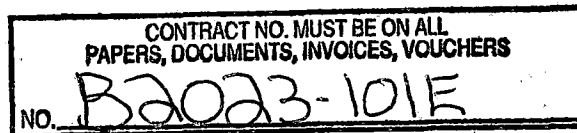

RESOLUTION

May 17, 2023

WHEREAS, on May 2, 2023, pursuant to legal advertisements therefor, sealed bids were received for the ROAD IMPROVEMENTS TO MASSACHUSETTS AVENUE (C.R. 637) AND COX CRO ROAD (C.R. 622), LAKEWOOD AND TOMS RIVER TOWNSHIPS NO. II, State of New Jersey; and

WHEREAS, at the advertised time, responses were received from the following bidders:

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has referred all bids to the County Engineer for study and recommendation to the Board; and

WHEREAS, the County Engineer has now recommended to this Board that the lowest qualified bid, according to specifications, namely that of, LUCAS BROTHERS, INC., be accepted for the Road Improvements to Massachusetts Avenue (C.R. 637) and Cox Cro Road (C.R. 622), Lakewood and Toms River Townships No. II.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Lucas Brothers, Inc., accepting their bid in the total amount of \$665,665.00; in accordance with plans and specifications prepared by the County Engineer. All work under this Contract shall be completed within **One hundred nine (109)** calendar days.

2. The Department of Finance has certified that funds are available in Account No. 210-185-0060 in the amount of \$7,500.00; Account No. 301-185-X008 in the amount of \$68,378.97; Account No. 420-185-X008 in the amount of \$70,968.02; Account No. 300-185-X106 in the amount of \$204,029.78 and Account No. 422-185-X203 in the amount of \$314,788.23 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.

3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2023-101E.

4. BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to each of the following:

- a. County Auditor;
- b. County Department of Purchasing;
- c. Department of Finance; and
- d. County Engineer who shall see that the successful bidder enters into a proper contract for the faithful performance of their bid and that said contract is duly filed with the Clerk of this Board; and who shall see that the successful bidder furnishes to the County of Ocean a properly executed surety company bond for the faithful performance of their contract.
