**RESOLUTION**

May 06, 2026

**WHEREAS**, on January 21, 2026, the Ocean County Board of Commissioners awarded a Competitive Contract to provide **Year Two, Older American Act, Title III Area Plan Contract 2026** to Bright Harbor Healthcare for Social Support Services to the elderly of Ocean County, in an amount not to exceed \$150,000.00, for the period of 1/1/2026 through 12/31/2026, and was assigned Contract No. CC2026-26; and

**WHEREAS**, due to the closure of the County's Aid/Homemaker Services account in the permanent budget, it is necessary to amend the funding allocations and/or funding sources related to Social Support Services to ensure continuity of services and to maintain the total contract amount of \$150,000.00;

**NOW, THEREFORE, BE IT RESOLVED**, by the **BOARD OF COMMISSIONERS**, of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the contract dated January 21, 2026 is hereby amended to revise the funding allocations and/or funding sources related to the Social Support Services portion of the contract, with all other terms and conditions remaining in full force and effect, as follows:
