RESOLUTION

August 19, 2026

WHEREAS, on January 21, 2026, the Ocean County Board of Commissioners awarded a Competitive Contract to provide **Year Two, Older American Act, Title III Area Plan Contract 2026** to Mental Health Association in New Jersey, Inc. for Social Support and Evidence Based Health Promotion – Chronic Disease Services to the elderly of Ocean County, in an amount not to exceed \$161,678.00, for the period of 1/1/2026 through 12/31/2026, and was assigned Contract No. CC2026-28; and

WHEREAS, it is now necessary to amend the contract award as additional funds are available to increase the Evidence Based Health Promotion – Chronic Disease Services portion of the contract, an increase in an amount not to exceed \$10,356.00, for an amended total contract award in the amount of \$172,034.00.

NOW, THEREFORE, BE IT RESOLVED, by the BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, that the contract dated January 21, 2026 is hereby amended the funding allocations and/or funding sources related to Evidence Based Health Promotion – Chronic Disease Services portion of the contract, with all other terms and conditions to remain in full force and effect, as follows:
