RESOLUTION

August 19, 2026

WHEREAS, on January 21, 2026, the Ocean County Board of Commissioners awarded a Competitive Contract to provide **Year Two, Older American Act, Title III Area Plan Contract 2026** to St. Vincent de Paul, Our Lady of Guadelupe Conference for Social Support Services to the elderly of Ocean County, in an amount not to exceed \$10,000.00, for the period of 1/1/2026 through 12/31/2026, and was assigned Contract No. CC2026-29; and

WHEREAS, it is now necessary to amend the contract award as additional funds are available to increase the Social Support Services portion of the contract, an increase in an amount not to exceed \$10,000.00, for an amended total contract award in the amount of \$20,000.00.

NOW, THEREFORE, BE IT RESOLVED, by the BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, that the contract dated January 21, 2026 is hereby amended to increase the Social Support Services portion of the contract, with all other terms and conditions to remain in full force and effect, as follows:

BE IT FURTHER RESOLVED that the Director and Clerk of the Board are hereby authorized and directed to execute an amendatory agreement and any necessary subsequent related documents, with the Director of St. Vincent de Paul, Our Lady of Guadelupe Conference, to provide Social Support Services to the elderly contingent upon the availability of said funds.

BE IT FURTHER RESOLVED that a notice of this action shall be published once as required by law.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Finance, County Office of Senior Services, and St. Vincent de Paul, Our Lady of Guadelupe Conference.
