RESOLUTION

August 19, 2026

WHEREAS, on January 21, 2026, the Ocean County Board of Commissioners awarded a Competitive Contract to provide **Year Two, Older American Act, Title III Area Plan Contract 2026** to Community Services, Inc. of Ocean County for Social Support Services, Congregate Meal Services, Home Delivered Meal Services, and Weekend/Holiday Home Delivered Meal Services to the elderly of Ocean County, in an amount not to exceed \$3,507,880.00, for the period of 1/1/2026 through 12/31/2026, and was assigned Contract No. CC2026-30; and

WHEREAS, it is now necessary to amend the contract award as additional funds are available to increase the Home Delivered Meal Services portion of the contract, an increase in an amount not to exceed \$160,902.00, for an amended total contract award in the amount of \$3,668,782.00.

NOW, THEREFORE, BE IT RESOLVED, by the BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, that the contract dated January 21, 2026 is hereby amended the funding allocations and/or funding sources related to Home Delivered Meal Services portion of the contract, with all other terms and conditions to remain in full force and effect, as follows:
